#### **CONTEXT OF THE MISSION:**

The Global Health & Prevention Direction works to ensure that Sustainable Development Goals (SDG 3) "Ensure healthy lives and promote wellbeing for all at all ages" can become a reality for persons with disabilities and vulnerable populations all along the various Nexus contexts. We focus on inclusive health system strengthening, inclusive health programming and prevention of preventable impairments and we work on the following sectors: Safe and Inclusive Mobility (1 Specialist), Mental Health and Psycho social support (4 Specialists), Non communicable diseases (1 Specialist), Sexual and Reproductive health, including Family planning, HIV, Maternal, newborn and child health (2 Specialists) and Disability Inclusive Policies (1 Lead).

The Global Health & Prevention Direction works in close collaboration with the other technical Directions, namely Rehabilitation, Protection & Risk Reduction, and Social\_& Inclusion, as well as with the 5 Geographic Directions.

## **DESCRIPTION OF THE POSITION:**

HI is a leading actor in Sexual and Reproductive Health and Rights and Disability Inclusion, and one of the very few international NGOs advocating to promote disability inclusion in the Sexual and Reproductive Health and Rights agenda globally. We focus on equity in access to health information and services, disability inclusive programming, and integration of early detection and management of impairments linked with Sexual and Reproductive Health and Rights and MNCH in the existing health services.

In this context, we are looking for a dynamic disability inclusive Sexual and Reproductive Health and Rights Specialist motivated to provide technical support to the SRHR project portfolio including the "Ensemble" project recently launched by HI in collaboration with CARE International in West Africa, with the financial support of Global Affairs Canada, and the « Women's Integrated Sexual Health » (WISH2ACTION) project, the FCDO flagship Health program aiming to transform the lives of millions of women and girls. This program provides integrated and holistic healthcare to 2.2m additional users of contraception across 16 countries in Africa and South Asia from 2018-2021. We are currently waiting for confirmation of its extension to 2022.

Through a consortium of five internationally recognized organizations, WISH2ACTION program provides a comprehensive, integrated approach to ensure equitable access to family planning and Sexual and Reproductive Health and Rights (SRHR). The program prioritizes the most underserved women and girls, particularly youth under 20, the very poor, and marginalized populations.

Under the direct responsability of the Global Health & Prevention Director, the SRHR Specialist will have for main responsabilities:

1/To provide Technical support to ongoing SRHR projects, including WISH2ACTION (40% of time)

- > Develop and roll-out tools, resources, and trainings to improve disability inclusive program implementation
- Provide technical and programmatic support to build the capacity of in-country teams on Disability Inclusive SRH programming
- > Participate in the development and monitor of technical work plans and budgets, ensure appropriate levels of technical assistance in program interventions, coordinate partners' efforts in program implementation
- Undertake regular technical supportive supervision, mentoring and monitoring visits to project sites as necessary
- Work with and provide technical leadership and support to relevant project staff for effective program planning, implementation and monitoring

#### 2/To define the Technical frame

- Lead on the elaboration of HI's Disability Inclusive SRH policy paper and its internal and external dissemination
- Contribution to the elaboration, dissemination and implementation of the SRHR strategic action plan

### 3/To ensure continuous learning and knowledge management

- Explore and take advantage of opportunities to share/disseminate HI's SRH program evaluations results
- > Assists in preparing donor progress reports
- Facilitate knowledge generation and lessons learnt events within HI and with relevant stakeholders through, publications, webinars and other knowledge sharing forums
